All Equipment listed shall be installed per the manufacturers installation instructions. It is intended as an informational tool regarding what equipment will accept load controller CT's in the non-sealed, customer portion of the service equipment. Equipment not listed does not imply CT location in sealed utility area is permitted. Equipment shall have CT's located in the customer's side of the equipment. In all cases, APS Service Requirements and EUSERC Manufacturing Requirements shall apply. For specific questions regarding the service equipment, please contact the Manufacturer's Representative listed.
