NOTE: INCENTIVES ARE AWARDED ON A COMPETITIVE BASIS. SUBMITTING YOUR RESERVATION APPLICATION DOES NOT GUARANTEE PROJECT FUNDING.

Instructions for submitting Reservation Application:

1. Complete and submit a Reservation Packet. The reservation packet consists of:

- Copy of a contract with Installer or Developer executed by both customer and Installer or Developer for the installation of the System (**application will not be accepted without this documentation**)
- A quote from your installer providing itemized cost for the system
- A completed and signed Reservation Application

The Reservation Packet must be submitted electronically to commercial-incentives@aps.com.

APS will not accept incomplete applications. Please note:

- APS is not responsible for applications not received due to an undeliverable email address
- A reservation application will not be accepted unless it is signed by the APS customer of record
- A reservation application must be received by the nomination period deadline (which ends the last day of the nomination month)

2. Receive Reservation Confirmation

Funding for up-front incentives will be equally divided into six bi-monthly allocation periods and will be reserved for projects on a competitive basis. Please see the [decision process](#) on the APS website at www.aps.com/gosolar.

Please note that at the end of the nomination period, you will only be notified **if your reservation application is approved for funding**. If approved, you will also receive a Credit Purchase Agreement which must be signed and returned to APS within 45 days. Once the funding process is complete, the ranking score of the last accepted project will be posted on a link listed on the first page of our website at www.aps.com/gosolar. This posting will typically occur within 14 days of the close of the nomination period.

If your application is not approved in the current funding nomination period, unless you request it to be withdrawn, the application will automatically roll over to the next nomination period “as is” during the current calendar year. You may also submit an updated application, clearly marked “REVISED” on page 1 of the application.

If your reservation application is not approved for funding, and you choose to proceed with the installation, please note your equipment can only be considered “new” and eligible for an incentive for up to six months from the commissioning date of the system. Systems over six months old are not eligible under the APS incentive program.

Important Note:

If any information provided on the Incentive Application changes, please submit a signed amended incentive reservation application to APS at commercial-incentives@aps.com.

3. Complete and submit an APS Interconnection Application, along with AHJ approved diagrams. (Either you or your equipment dealer /installer can complete this step. Samples can be found at www.aps.com/dg).

4. **Receive preliminary approval confirming system design appears to meet APS interconnection requirements.**
APS will send comments regarding any required changes to the design of your system, along with an Interconnection Agreement which must be signed and returned to APS prior to commissioning the system.
5. **Proceed with installation and obtain necessary municipal clearances.** (Typically your equipment dealer /installer will assist you in obtaining any necessary clearances).
6. **Schedule APS Interconnection Inspection.**
Once you receive municipal clearance, please contact APS to request an interconnection inspection by APS. After inspection, APS will send you authorization confirming that the Wind System has passed inspection and that permission has been provided for the Wind System to operate in parallel to the APS distribution system. **Only an authorized APS representative can provide permission for your Wind System to operate in parallel to the APS distribution system. Until such permission has been granted, your Wind System will not be operable (in conjunction with the APS distribution system).**

If you plan for the system to be installed in 2012, the following year-end interconnect deadlines apply:

1. **October 5, 2012:** interconnection application (<http://www.aps.com/dg>) with a full set of AHJ approved stamped diagrams. (If there is no plan review requirement imposed by the municipality that the GF resides in, then APS will require drawings submitted per the APS Interconnection Requirements)
2. **November 16, 2012:** scheduling of inspection must be confirmed

7. **Request Incentive Payment.**

Please submit the following so that an incentive payment can be issued:

- Installation and Commissioning Certificate signed by both the dealer and the installer
- Copy of PAID invoice confirming final System purchase price, payment (paid in full, less any assigned APS incentive payment), and installation by an Arizona licensed contractor
- Copy of green tag / city clearance (or letter in lieu if applicable)
- Please include the project reservation # in your email when submitting these final documents, as not supplying the reservation # can cause significant time delays

If your reservation is approved, please note the following timelines:

1. **Your signed Credit Purchase Agreement must be returned to APS within 45 days of reservation date.**
2. **Submittal of an Interconnection Application, along with AHJ approved drawings, within 90 days of reservation date**
3. **A progress update is required at 120 days from reservation date, including status of the following:**
 - a. **Interconnection Agreement**
 - b. **Equipment orders**
4. **System must be installed within 180 days from reservation date.**

Projects not meeting timelines may be cancelled. If extenuating circumstances exist, you may request consideration for an extension by contacting APS at commercial-incentives@aps.com. If your project requires outside financing, it should be secured at the beginning of the application process. Please note that extensions will not be granted for lack of secured financing.
