NAVAJO SCHOLARSHIP PROGRAM APPLICATION**

The APS-Four Corners Power Plant, located on the Navajo Nation in northwest New Mexico, supports local college students for careers related to the electric utility industry.

The Four Corners Power Plant Navajo Scholarship Program provides financial aid assistance to area Navajo students pursuing undergraduate degrees in a utility related field of study. Payment of funds is made directly to the accredited educational institution's financial aid office.

Scholarship awards range from \$1,000 to \$1,500 per school year and are renewable each semester contingent on the recipient's good standing. Official school transcripts must be submitted before funds are disbursed for the following semester. Official transcripts must be submitted by July 2 for fall semester and February 1 for spring semester. Should a recipient fail to meet eligibility requirements or fail to submit an official school transcript by the deadline, the scholarship can be discontinued.

Selection is based on a variety of factors and not restricted to scholastic performance. Students who meet the following requirements are eligible for consideration:

- ❖ Resides, registered and/or attends an accredited educational institution in the Northern Navajo Agency and San Juan County (N.M.).
- ❖ Attending an accredited college/university/technical institution in a utility related field of study. Disciplines include but not limited to accounting, business administration, chemistry, communications, computer science, engineering, human resources, nursing, occupational safety and vocational programs (automotive, electrical, instrumentation, machinist, water treatment, welding, etc.)
- ❖ A minimum cumulative Grade Point Average (G.P.A.) of 2.50 on a 4.00 scale.
- ❖ A minimum semester G.P.A. of 2.00 on a 4.00 scale.
- ❖ Full-time status (minimum of 12 semester credit hours).

A completed, hardcopy application package signed and submitted by the deadline of July 2, 2018, which includes:

- 2018 application;
- Responses to three essay questions (telephone interview may follow);
- Two Letters of Recommendation describing the applicant's character by professional references only, i.e. professor, principal, teacher, counselor, community leader, etc.;
- Official* school transcript (envelope must be sealed);
- ACT/SAT scores (required for freshmen);
- Resume;
- Letter of Acceptance from the educational institution of choice for freshmen/transfer students; and
- Certificate of Indian Blood (CIB).

The Scholarship Selection Committee reviews applications and administers the selection process. There is no appeal process.

A COMPLETED APPLICATION PACKAGE MUST BE RECEIVED OR POSTMARKED BY MONDAY, JULY 2, 2018. THERE ARE NO EXCEPTIONS.
