APS PINAL ELECTRICAL IMPROVEMENT PROJECT

In April 2024, we announced the need for a new 230 kilovolt (230kV) power line to support growth in the Pinal County region and provide greater energy reliability in your communities. The new power line will connect with existing and future electrical transmission infrastructure. We have conducted environmental studies and held multiple meetings with representatives from Casa Grande, Coolidge, Eloy, Pinal County, and other jurisdictions in the study area. The public was invited to attend multiple open houses, both in person and virtually, to learn more about the project and provide input.

As a result of environmental studies, and feedback from your communities and other stakeholders, APS has identified a "Preferred Route" for the 230kV facilities (see included map), which APS has taken forward for permitting with the Arizona Corporation Commission (ACC).

On July 29, 2025, we applied for a Certificate of Environmental Compatibility (CEC) with the Arizona Corporation Commission (ACC). This project will be presented at a hearing before the Arizona Power Plant and Line Siting Committee (Siting Committee) in September 2025. If approved by the Siting Committee, the CEC will then be presented to the ACC for their consideration and final decision.

Environmental studies, community and stakeholder input and feedback has helped APS identify a Preferred Route for a new 230kV power line needed in your area, including structures and poles approximately 115 to 200 feet tall, placed in new or existing rights-of-way or easements up to 120 feet wide.



This project provides improved infrastructure to support the current and future needs of APS customers. This project will provide additional reliability for the APS transmission system in Pinal County.



A new 230kV power line will connect the Milligan Substation (Milligan Rd & Eleven Mile Corner Rd) to a future power line just south of the Pinal County Fairgrounds (see included map).



PROJECT FEATURES

Monopole (single-pole) structures are commonly used for new 230kV power lines, though various steel structure types may also be used. Structure heights would range from 115 to 200 feet in height for 230kV monopoles, depending on routing, terrain, and crossing of existing structures, including elevated roads and other power lines. New rights-of-way and/or easements, approximately 120 feet wide, will be needed.

PUBLIC HEARING

A multi-day public hearing is scheduled to begin Monday, September 8, 2025, at 1 p.m. at the Radisson Hotel Casa Grande, 777 North Pinal Avenue, Casa Grande, Arizona, 85122. Virtual attendance also will be available. Updates will be provided as they become available, including the virtual link for the hearing, at aps.com/pinalproject.

The first day of the hearing will occur 1 p.m.-5 p.m., and subsequent days will be 9 a.m.-4 p.m. The hearing is scheduled to end on or before Thursday, September 11, 2025. At the hearing, the Siting Committee will review evidence provided by our study team and other parties wishing to participate in the process.




