Notice of Hearing for the Proving Ground 500kilovolt (kV) Transmission Line Project (Docket No. L-00000D-23-0011-00214; Case No. 214)

Dear Interested Party,

The purpose of this letter is to provide you with information about a public hearing scheduled for the Proving Ground 500kV Transmission Line Project (Interconnection Project). The Project involves an approximately 0.6-mile-long, 500kV transmission line that would connect the Proving Ground Solar+Storage Project to the regional electric grid at the APS Hoodoo Wash Switchyard. The enclosed map shows the proposed route for the Interconnection Project. Additional information is available at swcavirtualpublicinvolvement.com/proving-ground and at aps.com/provingground.

Arizona Public Service Company (APS) filed an application for a Certificate of Environmental Compatibility (CEC Application) with the Arizona Corporation Commission (ACC) requesting approval to construct the Interconnection Project; the Interconnection Project is docketed as L-00000D-23-0011-00214. During the public hearings, the Arizona Power Plant and Transmission Line Siting Committee (Committee) will consider the CEC application, deliberate, and make a recommendation to the Arizona Corporation Commission.

Public hearings for the Project will start on **February 13, 2023, at 1 PM**, and will continue as necessary through February 15, 2023, commencing at 9 AM each day. The public is invited to attend hearings inperson, online, or via telephone. Hearings will be held at the **Yuma Four Points by Sheraton**, **located at 2030 S. Avenue 3E, Yuma, AZ 85365**.

At least 24 hours in advance of the hearing, information including virtual participation links and phone numbers, public health protocols, and any revisions to the hearing schedule will be noticed on the Project website at <a href="mailto:swcavirtualpublicinvolvement.com/proving-ground">swcavirtualpublicinvolvement.com/proving-ground</a>. Revisions to the hearing schedule will also be noticed on the ACC website (<a href="mailto:acc.gov/arizona-power-plant/meeting-schedule">acc.gov/arizona-power-plant/meeting-schedule</a>). If the Committee conducts a tour, the route tour and a map will be posted on the Project and ACC websites. Members of the public may follow the Committee on the tour.

The Committee will hear public comment on February 13, 2023, beginning at 5:30 PM; public comment may be delivered in-person at the **Yuma Four Points by Sheraton**, virtually, or via telephone. The Committee Chairman may, at his discretion, allow additional public comment at other times during the hearing.
