RUNWAY 230kV POWER LINE PROJECT

In Jan. 2022, we announced the need for a new double circuit 230-kilovolt (230kV) power line to serve the Microsoft data center. The new 230kV line would connect the APS Runway Substation, located on the Microsoft site in Goodyear, to existing transmission lines along the Agua Fria River in Avondale. It would also allow for a future connection of the planned Diamond Substation located to the east of the Microsoft data center. As of Sept. 2022, we have conducted environmental studies and held multiple meetings with representatives from the cities of Goodyear and Avondale, Maricopa County, and other jurisdictions in the the study area.

On Jan. 10, 2022, we launched a virtual public open house to provide project information and seek your

input. The virtual open house was updated on June 14, 2022, in coordination with our in-person open houses held on two nights during that same week.

- Community feedback during this process has helped us identify a preferred route and subroute alternatives, as shown on the included map.
- On Sept. 29, 2022, we filed an application for a Certificate of Environmental Compatibility (CEC) with the Arizona Corporation Commission (ACC). This project will be presented at a hearing before the Arizona Power Plant and Line Siting Committee (Siting Committee) in Nov. 2022. If approved by the Siting Committee, the CEC will then be presented to the ACC for their consideration and final decision.

This new power line is needed to support the redundancy needs of the Microsoft data center, would allow for a connection to the future Diamond substation, and enhance reliability to the surrounding transmission infrastructure.



Your feedback has helped identify the proposed routing for this new power line, which would connect an existing 230kV transmission line near the Agua Fria River and Buckeye Road in Avondale, to the Runway Substation NE of Bullard Ave. and Broadway Rd. in Goodyear (see attached map).



PROJECT FEATURES*

A variety of steel monopole (single pole) structures will be used for the new transmission line, and will range in height from approximately 115 feet to 195 feet depending on routing, terrain, and crossing of existing structures, including elevated roads and other power lines.

Any opportunity to utilize existing power line routes for the new 230kV structures will be considered. However, new rights-of-way and/or easements (approximately 60 feet each side of the structure totaling 120 feet) will be needed.

*Exact structure, height, and right-of-way and/or easement widths may vary.

PUBLIC HEARING

A multi-day public hearing is scheduled to begin Monday, Nov. 14, 2022 at 1 p.m. at the Hilton Garden Inn, 11460 West Hilton Way, Avondale, Arizona, 85323. Virtual attendance also will be available. Updates will be provided as they become available, including the virtual link for the hearing, at aps.com/runway.

The first day of the hearing will occur 1 p.m.-5 p.m. and subsequent days will be 9 a.m.-4 p.m. The hearing is scheduled to conclude on or before Friday, Nov. 18, 2022. At the hearing, the Siting Committee will review evidence provided by our study team and other parties wishing to participate in the process. Public comment will be taken Monday, Nov. 14 starting at 5:30 p.m. The public is invited to comment either in person or virtually. If the Siting Committee approves our application, they will issue a CEC, which will be submitted to the ACC for its consideration.


