APS WESTWING 230KV INTERCONNECTION PROJECT

We are proposing to build the APS Westwing 230kV Interconnection Project, a new 230-kilovolt (kV) transmission line needed to interconnect a separate customer-proposed battery electrical storage project to the existing Westwing Substation.

The proposed battery electrical storage facility will enhance our electric system throughout the Phoenix metropolitan area. With this facility comes a need for a new 230kV transmission line to interconnect the

To interconnect the planned customer battery storage facility north of the Westwing Substation with our system in order to enhance the capability of the system and allow flexibility in the delivery of power to customers.



We will rebuild and co-locate the new transmission line with an existing 69kV line that runs adjacent to and between the customer proposed battery storage project, located south of Happy Valley Road and east of the El Mirage Road alignment, and the Westwing Substation, located south of Happy Valley Road, west of Loop 303.

TYPICAL STRUCTURES*

We work hard to balance the energy needs of our customers while protecting the environment and natural beauty of the area.

The rebuilt transmission line structures will consist of doublecircuit 230kV steel monopoles with a double-circuit 69kV built lower on the pole. The steel monopoles are anticipated to be up to 150 feet in height, which is generally shorter than nearby existing transmission structures.

*Exact structure, height and right-of-way width may vary

ARIZONA POWER PLANT AND TRANSMISSION LINE SITING COMMITTEE (APPTLSC) HEARINGS

The next step for this important project is a hearing before the APPTLSC. All transmission lines in Arizona with a voltage of 115kV or greater are required through state statute to receive a Certificate of Environmental Compatibility (CEC) from the Arizona Corporation Commission. The most important part of the process is the APPTLSC hearing, which is scheduled starting on **August 23, 2021 commencing at 1pm and continuing August 24 through August 27, 2021 commencing at 9am** each day as necessary through the completion of the hearing at the *Double Tree by Hilton, Phoenix North* located at **10220 N. Metro Pkwy E., Phoenix, AZ 85051.**

Members of the public and all interested parties are invited to attend the hearing. However, due to the ongoing pandemic, you are strongly encouraged to participate by either watching the meeting online or listening to the meeting via telephone, rather than attending in person. At least 24 hours in advance of the hearing, information regarding online and telephone hearing access will be posted on the project website at <u>aps.com/</u> <u>westwingproject</u> and available by calling (623) 303-3796.
